The Elizabethan Syngers are committed to providing a safe and healthy environment for all our members[and customers, clients, patrons, guests and visitors]. To ensure we have safe and healthy rehearsal/performance, The Elizabethan Syngers has developed the following COVID-19 Preparedness Plan in response to the COVID-19 pandemic. Board/Leadership and members are all responsible for implementing this plan. Our goal is to mitigate the potential for transmission of COVID-19 in our workplaces and communities, and that requires full cooperation among our members. Only through this cooperative effort can we establish and maintain the safety and health of all persons in our rehearsal and performance spaces.

The COVID-19 Preparedness Plan is administered by Barb Young, who maintains the overall authority and responsibility for the plan. However, Board members and summer session members are equally responsible for supporting, implementing, complying with and providing recommendations to further improve all aspects of this COVID-19 Preparedness Plan.

Our Syngers are our most important assets. The Elizabethan Syngers are serious about safety and health and protecting our members. Member involvement is essential in developing and implementing a successful COVID-19 Preparedness Plan. Please find below the plan as approved by The Elizabethan Synger Board.

***\*All participating members are required to be fully vaccinated before starting in person rehearsals\****

### **Guidelines for Rehearsal:**

- All Syngers may wear masks during rehearsals, it is up to user preference
- When rehearsing inside, windows will be opened for air circulation
- If you are wearing a mask, all masks must successfully cover your nose and mouth
- If you are feeling ill, do not attend, follow State and CDC guidelines and contact Plan Administrator
- At the end of each rehearsal, Syngers will be required to sanitize the surfaces they were using/touching/in contact with
- There will be no outside members at rehearsals (i.e. family members, friends). Only Syngers will be at rehearsals

-During rehearsals Syngers may be asked the following questions prior to each rehearsal:

-I am not experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.

-I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.

-I have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non contagious by state or local public health authorities.

-I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

### **Guidelines for Performances(Synger and Audience):**

-All audience members must wear masks or face coverings for indoor performances

-All masks must successfully cover your nose and mouth

-All audience members will be required to social distance from each household

-If you are feeling ill, do not attend

-Syngers will adhere to site specific rules and regulations during performances

### **If Covid is contracted:**

-If you have been in contact with a Covid positive person, Synger must stay at home until they have completed the necessary quarantine time or have quarantined and tested negative for Covid as in accordance with State and CDC guidelines

-All in person rehearsals will switch to virtual until proper tests and quarantining can take place in accordance with State and CDC guidelines

-The Elizabethan Syngers would never intentionally put anyone's life in danger, but there is inherent risk involved until herd immunity is reached

***Note:****The Elizabethan Syngers will adhere to any and all rules in place at any off site performance site*
